Election Special General Body Meeting of the Income Tax Department Co-operative Society Ltd., Regd. No. MSCS/CR-11/90, Chennai – 600 034 will be held at 01.30 p.m. on 19-04-2021 (Monday) at Income Tax Auditorium (Main Building Complex), No.121, Mahathma Gandhi Salai, Chennai – 600034 to ELECT ELEVEN DIRECTORS (11) to the Board of Directors of the Income Tax Department Co-operative Society Ltd., Regd. No. MSCS/CR-11/90, Chennai – 600034.

Out of Eleven Directors to be elected, Two (2) are reserved for women and One(1) Directorship will be reserved for SC/ST member and remaining 8 (Eight) will be among general category of members.

The Election of the 'Board of Directors' will be held in accordance with the Multi State Co-operative Societies Act and Rules and Bye-Laws of the Society.

The Term of the Elected Directors shall be FIVE YEARS from the Date of Assumption of Charges.

If the number of contesting candidates in respect of whom valid nominations have been received does not exceed the number of candidates to be elected, such candidates shall be deemed to have been elected unopposed.

If the number of valid nominations exceeds, the number of Directors to be elected from those candidates either general constituency and / or Reserved for women and / or SC/ST, a POLL shall be held and the Returning Officer shall then read out the names of the contesting candidates and the election will be held by a Secret ballot as per the Bye laws of the Society.

In case polling is held, counting will be conducted on 11-05-2021 (Tuesday) at 10.00 a.m. (Results will be announced after completion of counting of votes).

Those, who are filling nominations for directorship reserved for SC/ST are required to produce either a valid community certificate issued by competent authority or copy of the relevant pages of service register certified by the Head of Office.

- No Member is eligible to contest in the election unless such member is qualified with reference to the provisions of the Multi State Co-operative Societies Act and Rules and the Bye Laws of the Society.
